- 2. Bidders must submit attested photocopies of valid GST registration Certificate, last year Income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be, PAN, ADDHAR details.
- 3. Preference will be given that contractor whose having credentials of 30% of similar nature of work during last three years.
- 5. Bidders must quote rates in absolute numerical values (both in figures and words) against the estimated cost. Rate quoted in only percentage term will be rejected.
- 6. Rate offered by bidder in a particular Tender shall be treated as final and subsequent negotiation with the bidder for changed in price shall not be allowed.
- 7. Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
